Roll Call Information

Roll call will be done on an individual, on-going basis. Each dog will be inspected just prior to running. Dogs will be inspected for signs of lameness, injuries, or other signs of distress. Females "in season" will not be permitted to run.

Entry Information

Advance Passes:

Passes can be obtained prior to the event by sending a completed Entry Form (use form in premium) and a check to Dog Sports Unlimited at 875 Tater Rd. New Smyrna Beach FL 32168. Any forms not completed correctly or with inaccurate information will not be accepted.

Day of Event Passes:

Entry forms will be available on site. Fee will be \$30

Dogs must be at least 1 year old on the day of the event in order to compete.

Any person that writes a check with insufficient funds to cover will be assessed a \$30 fee per check.

Refunds may not be provided if any portion of the event is cancelled due to acts of God.

Event closing times can be extended or adjusted for reasons associated with weather delays or other unforecast or unforeseen events that occur during the course of the Fast CAT tests.

Ribbons and Prizes

Light blue flat ribbons will be awarded for all dogs successfully completing a Fast CAT event.

Rosettes will be awarded for all dogs making a title run. If possible, let us know in advance that your dog will be earning an FCAT 2 or greater.

Terms of Participation

All dogs must be on a leash except for when running.

Dogs are not permitted to run while wearing prong collars or choke chains. Prong, choke, and electric collars are not allowed on trial grounds.

No person is allowed on the track without the permission of the lure operator or Huntmaster.

Sequencing of runs is based on first come first served but can be altered at the discretion of the lure operator or Field Trial Committee.

Dog substitutions are permitted but the dog must be inspected prior to running.

Each dog entered must be physically fit enough to run and have no known medical condition that would be adversely affected by participating in the event. Bitches in heat are not allowed to run. In cases of a bitch in season or a dog being injured, entry fees will be refunded.

An electronic, continuous loop machine will be used to pull plastic bags or a squawker.

The track will be fenced.

Light curtain gates will be used for timing.

For the sake of good sportsmanship and sanitation, handlers shall use their best-efforts to keep their dogs from relieving themselves anywhere in or around the fenced track area.

In the event of rain, hand held timers may be used in place of light curtains.

The Field Trial Committee reserves the right to prohibit any dog and/or handler from the site.

Be considerate and pick up all dog waste and dispose of it properly.

Unsportsmanlike conduct is grounds for being excused from the field and possibly subject to further disciplinary action by the AKC.

Dogs may be measured at any time to determine their handicap category.

Helpful Hints

Make sure you have your AKC number for any dog you plan on running.

It takes 2 people to run a dog—one to release and one to retrieve. Plan accordingly.

Bring water containers for your dog. We have plenty of water available at our location.

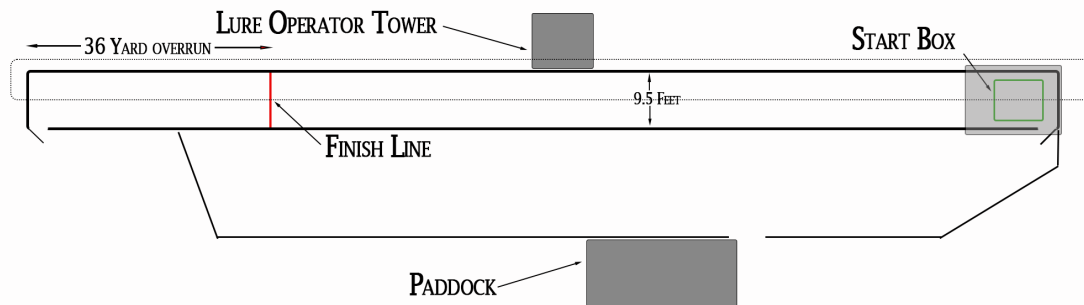
This location has few shade trees. Bring your own shade if you will be keeping dogs on site.

Parking is available near the site so your vehicle can be close to the track.

Arrive early to get your place in line.

Track Layout and Description

DOG SPORTS UNLIMITED
NEW SMYRNA BEACH, FL



The above diagram displays the dimensions and layout of the Fast CAT track at the Dog Sports Unlimited New Smyrna Beach facility. The course is located on the northern most section of the property and is oriented in an east-west direction. The timed portion of the track is the 100 yards. There is 36 yards of track beyond the finish line.

The Hunt Master tent is a 10 x 20 feet tent that provides cover for the Hunt Master and participants at the Start Box.

The Lure Operator stands in an approximately 5 foot high covered tower adjacent to the track at approximately the mid-point of the course. A continuous loop lure system is used to move the lure. All pulleys used are situated outside the fenced portion of the track.

The Timer is also located in the tower. The official time is displayed in the tower and relayed to the Huntmaster, where it is recorded on the dog's qualifying ribbon and run ticket.

Dogs that have been inspected report to the Paddock with their run ticket. The Paddock Master will put their dog on the run board and when it is their turn to run, they will proceed through the opening of the track apron and stop at the gate at the start end of the track. Once the Hunt Master allows them to enter the track, the dog will be situated in the start box. On the Hunt Master's signal, the lure will be put in motion and the dog will follow the lure across the finish line where the catcher will recover the dog and exit the track through the gate at the end of the track.

10 inch LED displays affixed to the front of the lure operator tower show the time and speed for each dog's run.

There is a gate at the midpoint of the track but it should only be used with permission from the Lure Operator, Hunt Master, or Paddock Master.
